## **Job Description LABORER**

**Department:** Sanitation

**Hours:** 7:00 a.m. to 3:00 p.m.

Monday through Friday (with other shifts possible)

**Immediate Supervisor of the Position:** Superintendent of Public Services (or his designee)

**Rate of Pay:** \$19.73/Entrance; \$20.22/Step 1 (1 yr.); \$20.72/Step 2 (2-5 yrs.); \$21.24 Step 3 (6-10 yrs); \$22.09/Step 4 (11+ yrs.) per hour, (\$1.00 per hour less if less than 120 days of service)

### **General Statement of Duties:**

A laborer primarily collects refuse along waste collection routes and transports waste to a transfer station and/or landfill. Refuse collection and recycling duties are added as necessary.

### **Examples of Duties and Responsibilities:**

- Lift garbage bags and/or cans into garbage truck
- Pick up yard waste and tree limbs
- Assist in various waste recycling activities
- Able to carry out written and verbal orders efficiently
- Able to operate power tools as needed
- Lift furniture, tires and waste materials from public and private property
- Collect litter from right-of-way and public areas
- Lifting and delivery of heavy materials to job sites
- Clean job sites and public property with periodic supervision of others
- Periodic upgrade to equipment operators position

### **Knowledge of and Demonstrated Skills Required:**

- Ability to drive a garbage truck
- Follow orders, rules, maps and direction for refuse pick up
- Capable of independent and responsible action
- Able to work safely and have a safe driving record
- Must be able to communicate effectively with the public
- Reading written orders and write reports

### **Physical Requirements of Person Filling this Position:**

- Lift (approx. 30") and place approx. 1500 bags/cans (approx. 25 lbs. each) into garbage truck each day
- Walk prolonged distance over refuse collection route
- Must be able to lift heavy objects over his/her head
- Push containers of 600 to 1000 lbs. to the truck
- Work outside in all weather conditions
- Must be in excellent health and physical condition
- Must be able to walk through rough terrain
- Must have good sight and hearing

- Must have high school diploma or equivalent
- **Must currently possess a State of Ohio "Class B" Ohio Commercial Driver's License**
